INSTALLING ACTIVITY REPORT MANAGER SOFTWARE

- Have Microsoft Windows up and running
- Insert Disk 1 of Activity Report Manager in drive A:
- Choose FILE/RUN from the Program Manager in Windows 3.1 or START/RUN in Windows 95
- Type A:\SETUP and click the OK button
- Follow the on-screen instructions

Activity Report Manager is an intuitive program and does not come with a user's manual. Instructions for use can be found under the HELP menu.

LOGGING ON

- ♦ Select the Security Menu at the top of the screen, then click on Enable Security. This gives the necessary icon and will require the need to log on to view and operate the Activity Report Manager.
- Click the Log On icon next to the Help icon at the top of the screen or go to File and click Log On.
- Type in "Admin" for both user name and password.
- To add new users to the Activity Report Manager, select the Security menu at the top of the screen, then select Maintain Users. Click the Add button to add new users. After adding at least one new administrator, you can delete "Admin" as a user name.

INSTALLING HARDWARE "KEY" AND CHANGING THE CONNECTOR ON PRINTER CABLE

Remove printer connector from cable shipped with the DMP printer card and replace with the communication port connector issued with the ARM software. NOTE: This connector is intended for use on Comm Port 2 only. If you need to use Comm Port 1, you will need to purchase a 25-pin male connector that reduces to a 9-pin female connector.



 Remove the computer's printer cable from the back of the computer. Install hardware "key" on the computer's printer port, then reinstall printer cable piggyback style onto the hardware "key".
